COVID Outbreak Contingency Plan- September 2021

When should
my child self-
isolate or miss
school?

- All children MUST attend school unless they are ill.
- From 16th August 2021 children under the age (or double vaccinated adults) do not need to self-isolate or miss school if a member of their household or a contact has COVID. Instead they need to book a PCR test but continue coming to school, if they have no symptoms and the test result comes back negative.
- If your child develops COVID symptoms at home, they should <u>stay at home</u> and you should book a PCR test for them (not a lateral flow test).
- If your child develops COVID symptoms at school, they will be sent home and **you should book them a PCR test.**

If your child tests positive for COVID, they will need to self-isolate. The rest of the household does not need to isolate if they are under 18 or fully vaccinated-but instead should book a PCR test.

One child tests positive	-A single child tests positive for COVID in a class -There are fewer than 5 cases in a year group -No other year groups are affected	-The child self-isolates for 10 days. Remote learning will be provided, if they are well enough to completeThe parent/carers of the child are contacted directly by NHS Track and Trace to establish likely contactsLikely contacts will be contacted by NHS Track and Trace and advised to book a PCR testChildren that have been identified as close contact do not need to miss school or self-isolated whilst they are waiting for PCR test results, unless they develop COVID symptoms.
5 children or staff within a year group test positive within 10 days of each other	There have been 5 cases of COVID across a year group within 10 days, which could mean that COVID is spreading within a group	-As above for positive casesThe school will discuss the outbreak with Nottinghamshire Public Health and agree strengthening protective measures for 10 school days. These may include: reintroduction of face-masks for staff in communal areas, adapting curriculum provision and limiting visitors into class.
COVID cases continue to rapidly increase within a 10 day period	Despite the actions indicated above, COVID cases within school continue to rise within a 10 day period, with multiple classes and staff affected	-Meeting held between the school and Nottinghamshire public health to agree further actions and measures for an additional 10 days. These may include: reintroduction of class-bubbles, reverting to staggered end of day times, postponing identified events, identifying areas for a dep clean and reintroducing remote learning for 10 days,
